

**STAFF'S REQUEST TO MODIFY
PROCEDURAL SCHEDULE**

11 The Utilities Division ("Staff") of the Arizona Corporation Commission ("Commission")
12 hereby notifies the Administrative Law Judge (ALJ) that Staff is in the process of finalizing a
13 settlement agreement with the Company and the other parties that have intervened in this matter.
14 According to the procedural schedule set in this matter, Staff/Intervenor Rate Design Testimony is
15 currently due on July 26, 2013. Since the parties are in the process drafting a settlement agreement,
16 Staff requests that the ALJ suspended this date. In the event the Parties reach settlement, the parties
17 will file the Settlement Agreement on August 12, 2013 as specified in the April 30, 2013 Procedural
18 Order, and the case will proceed pursuant to the settlement track set forth in that procedural order. In
19 the event that parties are unable to settle, Staff will notify the ALJ and request further modification to
20 the procedural schedule as may be necessary. Staff was able to contact RUCO, and RUCO does not
21 object to this request. However, Staff did not have an opportunity to contact the other parties,
22 nonetheless wanted to inform the ALJ of the status of this matter.


