PROCEDURAL ORDER

BY THE COMMISSION:

On November 3, 2011, Clear Springs Utility Company, Inc. ("Clear Springs" or "Company") filed with the Arizona Corporation Commission ("Commission"), an application for authority to incur long-term debt ("Finance Application"), as well as a request for a rate increase ("Rate Application").

On July 2, 2013, a Recommended Opinion and Order ("ROO") was docketed in the matter advising the Company that the Commission would tentatively consider the ROO during the July 17 and 18, 2013, Open Meeting and that any exceptions to the ROO should be filed no later than 4:00 p.m., July 11, 2013.

On July 11, 2013, Clear Springs filed a Motion for Extension of Time to File Exceptions. The Company noted that the item had been rescheduled for the August 13 and 14, 2013, Open Meeting. Clear Springs also stated that it received the ROO on July 3, 2013. Because of the July 4th Holiday, the Company only had five business in which to draft its exceptions and requested additional time to prepare them for filing.

Given the circumstances, the Clear Springs' request is reasonable and should be granted.
