**STAFF'S REQUEST FOR CLARIFICATION**

Arizona Corporation Commission Staff ("Staff") files this Request for Clarification of the Recommended Opinion and Order ("ROO") dated July 2, 2013. Staff requests that the ROO be amended to clarify the 7th Ordering Paragraph on page 18, lines 1-2 to specify the form of Best Management Practices ("BMPs") to be filed by Vail Water Company ("Vail" or "Company").

To comport with the testimony of its witness, Marlin Scott, Jr., Staff requests that the following language be inserted after the word "tariffs" at the end of the above-referenced Ordering Paragraph:

"in the form of tariffs that substantially conform to the templates created by Staff for Commission review and approval, as set forth on the Commission's website."

This clarification will specifically identify the format for such BMPs for the benefit of the Company in order to facilitate its compliance with the ROO and the Commission's review and approval thereof.
