BY THE COMMISSION:

On July 12, 2013, Arizona Public Service Company ("APS") filed with the Arizona Corporation Commission ("Commission") an application for approval of Net Metering Cost Shift Solution.

Numerous public comments have been filed.

On July 26, 2013, an Application for Leave to Intervene was filed signed by Anne Smart, Executive Director of The Alliance for Solar Choice ("TASC").
