BY THE COMMISSION:

Having considered the entire record herein and being fully advised in the premises, the Arizona Corporation Commission ("Commission") finds, concludes, and orders that:

FINDINGS OF FACT

1. In Decision No. 59714 (June 26, 1996), the Commission granted Syufy Enterprises/Century Theaters ("Applicant") a Certificate of Convenience and Necessity ("Certificate") to provide customer-owned pay telephone ("COPT") service in Arizona.

2. On February 27, 2013, the Applicant's current controlling shareholder, Cinemark USA, Inc. ("Cinemark"), filed with the Commission an application for cancellation of the Certificate ("Application").

3. On June 10, 2013, the Commission's Utilities Division ("Staff") filed its Staff Report. Staff stated it had contacted Cinemark's Communication Coordinator, Jeff Turrentine, regarding the Application, and confirmed that Mr. Turrentine is authorized to file the Application. Mr. Turrentine stated that the Applicant does not provide COPT service in Arizona and does not wish to have a hearing on the Application.

IT IS FURTHER ORDERED that this Decision shall become effective immediately.


