

SCOTT WOOTTON, PRESIDENT OF DESERT VALENCIA WATER, INC., being first duly sworn upon his oath, deposes and states:

1. I am the President and manager of Desert Valencia Water, Inc. and am familiar with the company water testing and matters currently before the Arizona Corporation Commission under Docket Numbers W-02059A-11-0172 and W-20801A-11-0172.
2. This Affidavit is provided in compliance with Item 22(i) of the Opinion and Order issued by Administrative Law Judge Marc E. Stern
3. Testing of coliform for all water for potable use has been occurring monthly since May 2012. In all of the tests performed to date, the results indicated that both total coliform and E. coli were absent from the water samples.
4. The annual test for nitrate/nitrite was performed March 15, 2013. The result was "N.D." or "not detected at or above the reporting limit".
5. Original test reports are maintained in the records at the Company Offices.
