**JOINT REQUEST FOR
MODIFICATION OF
PROCEDURAL SCHEDULE**

UNS Electric, Inc. ("UNS Electric") hereby requests a modification of the procedural schedule in this docket. A settlement has been reached among all parties to this docket and a settlement agreement is now being drafted. All parties to the docket intend to file Direct Testimony in Support of the Settlement. However, given other obligations of the parties and a related delay in commencing settlement negotiations in this docket, the parties request an extension of time to file the settlement agreement and to submit direct testimony supporting the settlement agreement. Consequently, the parties also believe that it is no longer necessary to file responsive testimony regarding the settlement agreement. Therefore, the parties propose modifying the schedule as follows:

Settlement Agreement to be docketed on or before August 26, 2013 (currently due August 12, 2013)

Direct Testimony in Support of Settlement to be filed on September 20, 2013 (currently due August 26, 2013)

No Settlement Response Testimony (currently due September 9, 2013)

1 The hearing would still commence on September 30, 2013 as currently scheduled and all other
2 aspects of the February 7, 2013 Procedural Order, as modified by the Procedural Order issued on
3 February 11, 2013, would remain in full force and effect.

4 Commission Staff, RUCO and Nucor have informed UNS Electric that they are in
5 agreement with this modification of the procedural schedule and have given UNS Electric
6 authority to make this request on their behalf.
