
The Town of Tusayan ("Town") through its counsel submits this Status Report in response to the Procedural Order issued May 2, 2013. The Procedural Order requested that each party provide monthly updates. On July 26, 2013, the undersigned received a copy of what is described as a final draft of the Settlement Agreement in this matter. The Town has placed this matter on the agenda for action by the Tusayan Town Council at a meeting to be held on August 7, 2013. Although no action regarding the Settlement Agreement can be taken until the Town Council meets in a duly called meeting of the Town Council, the undersigned has recommended approval of the Settlement Agreement

1 and believes that it will be favorably considered at the August 7, 2013 meeting of the
2 Tusayan Town Council.

4 The Procedural Order issued on May 2, 2013 requested the parties to comment on
5 the scheduling of an evidentiary hearing for this matter and the establishment of additional
6 procedural requirements and deadlines. The Town anticipates that a procedural schedule
7 can be established at the procedural conference that is set for August 20, 2013.
