PROCEDURAL ORDER

BY THE COMMISSION:

On August 10, 2012, Far West Water & Sewer Company ("Far West" or "Company") filed a Motion to Close Docket in the above-captioned matter on the grounds that Far West had filed a new Rate Case (Docket No. WS-03478A-12-0307) ("2012 Rate Case").

No party responded to Far West's Motion.

The hearing in the 2012 Rate Case has concluded.

By Procedural Order dated July 2, 2013, parties to the 2008 Rate Case were requested to file any objections to Far West's Motion by July 26, 2013, and informed that if no objections were received, the matter could be administratively closed.

No party filed an objection to closing this docket. On July 10, 2013, the Residential Utility Consumer Office ("RUCO") filed a Notice of No Objection to the closure of this docket.
