Dear Mr Shand:

On August 21, 2012, the Arizona Corporation Commission approved Decision No. 73354 (the "Decision"), which determined that CenturyLink-QC's retail services are competitive under Section R14-2-1108 of the Commission's rules. In addition to the competitive determination for retail services, the order also provided that "the procedures for setting rates established in the Price Cap Plan approved by the Commission in Decision No. 68604 (Docket No. T-01051B-03-0454) will be superseded by implementation" of the provisions of the settlement agreement in the Decision.

The attached Competitive Private Line Transport Services Tariff No. 6 pages, which constitute a complete reissuance, of the tariff, are being filed to remove references to the now obsolete Price Cap Plan and also to change the Company name from Qwest Corporation to Qwest Corporation d/b/a CenturyLink-QC. Inasmuch as the reclassification of the Company's retail offerings as competitive services under R14-2-1108 did not affect any services in the Competitive Private Line Transport Services Tariff, these pages contain no substantive changes to the rates, terms and conditions found therein.

Pursuant to our earlier conversation, as a compliance item in this docket, I am enclosing two copies of the Competitive Private Line Transport Services Tariff No. 6. The issue date of the tariff is August 8, 2013. Since this is a compliance tariff and does not require further Commission action to become effective, we have shown the effective date as August 9, 2013. As always, the Company agrees to make any corrections that Staff may subsequently deem necessary in the event that it finds anything inconsistent with the Commission's decisions.
