PROCEDURAL ORDER

**BY THE COMMISSION:**

On July 3, 2013, Holiday Enterprises, Inc. d/b/a Holiday Water Company ("Company") filed an application with the Arizona Corporation Commission ("Commission") for a permanent rate increase under Docket No. W-01896A-13-0238 ("Rate Application").

Also on July 3, 2013, the Company filed an application for authority to incur long-term debt under Docket No. W-01896A-13-0239 ("Finance Application").

The Commission's Utilities Division ("Staff") docketed a Letter of Sufficiency on July 31, 2013, in the Rate Application docket advising the Company that its Rate Application met the sufficiency requirements of Arizona Administrative Code R14-2-103, and that the Staff Report regarding the Rate Application would be docketed on approximately October 14, 2013.

Because Staff's evaluation of the Finance Application may depend upon the Staff's findings in the Rate Application, a procedural conference is necessary to discuss whether the Rate Application docket and the Finance Application docket should be consolidated.

IT IS THEREFORE ORDERED that a **telephonic procedural conference** shall commence on **August 22, 2013, at 9:00 a.m.**, call-in number: (888) 450-5996, Participant No. 457395#. The parties may also attend in person at the Commission's Tucson offices, 400 West Congress Street, Room 218, Tucson, Arizona 85701.


IT IS FURTHER ORDERED that this procedural conference shall be held concurrently with a procedural conference scheduled in the Finance Application docket.

1 IT IS FURTHER ORDERED that the *Ex Parte* Rule (A.A.C. R14-3-113 - Unauthorized  
2 Communications) applies to this proceeding and shall remain in effect until the Commission's  
3 Decision in this matter is final and non-appealable.

4 IT IS FURTHER ORDERED that all parties must comply with Rules 31 and 38 of the Rules of  
5 the Arizona Supreme Court and A.R.S. § 40-243 with respect to practice of law and admission *pro hac*  
6 *vice*.

7 IT IS FURTHER ORDERED that the Administrative Law Judge may rescind, alter, amend, or  
8 waive any portion of this Procedural Order by subsequent Procedural Order or by ruling at hearing.


