**Motion to establish schedule
for SIB Testimony**

10 Global Water – Palo Verde Utilities Company, Global Water – Santa Cruz Water
11 Company, Valencia Water Company – Town Division, Valencia Water Company – Greater
12 Buckeye Division, Water Utility of Greater Tonopah, Willow Valley Water Co. and Water Utility
13 of Northern Scottsdale (collectively, the “Global Utilities”) and Global Water Resources, Inc.,
14 Hassayampa Utility Company, Inc., Global Water – Picacho Cove Utilities Company and Global
15 Water – Picacho Cove Water Company (collectively, the “Global Intervenors”, and with the
16 Global Utilities, “Global”) respectfully move that the Administrative Law Judge issue a
17 Procedural Order adopting the following schedule to address the System Improvement Benefit
18 (“SIB”) Mechanism issue:

19 Global to file testimony supporting SIB Mechanism: August 21, 2013

20 Staff Report or Staff Testimony regarding SIB: August 28, 2013

21 Responsive Testimony by Global or Intervenors: September 3, 2013

22 Global is proposing a SIB Mechanism for Willow Valley Water Co., Inc. only. The SIB issue was
23 not resolved in the Settlement Agreement filed on August 13, 2013 (See Section 1.4). Therefore,
24 it is reasonable and necessary to establish a schedule to address the SIB issue. Counsel for Global
25 has discussed the SIB schedule with counsel for the other parties interested in Willow Valley
26 system (Staff, RUCO and the Willow Valley Club Association), and counsel for all the interested
27 parties agree to the above schedule. Although RUCO does not object to the establishment of a

1 procedural process for submitting testimony, RUCO does not waive its right to object to the
2 timeliness of the application for the SIB and what they believe is a late-filed request.
3 Accordingly, Global requests that this schedule be approved.
