PROCEDURAL ORDER

BY THE COMMISSION:

In Decision No. 73912 (June 27, 2013), the Arizona Corporation Commission ("Commission") approved a Settlement Agreement that authorized a rate increase for Tucson Electric Power Company ("TEP"). The Decision also approved an Energy Efficiency Implementation Plan for TEP that superseded the plan that was proposed in the above captioned docket. Section 7.5 of the Settlement Agreement that was approved, provided that TEP would file a request to close Docket No. E-01933A-11-0055.

On July 31, 2013, TEP filed a Notice of Withdrawal in Docket No. E-01933A-11-0055, and requested to have this docket administratively closed.

No party filed an objection to the request.

IT IS THEREFORE ORDERED that pursuant to the Commission's directive in Decision No. 73912, Docket No. E-01933A-11-0055 is hereby administratively closed.


