("UNS Electric"), through undersigned counsel, hereby requests a modification of the procedural schedule in this docket to extend the deadline to file the settlement agreement until September 6, 2013. As indicated in the August 1, 2013 Joint Motion for Modification of Procedural Schedule, a settlement has been reached among all parties to this docket. Although the parties have diligently been working to finalize the settlement agreement and the associated attachments and schedules, additional time will be needed to complete the work. All parties to the docket still intend to file Direct Testimony in Support of the Settlement on September 20, 2013. Accordingly, the parties request that the procedural schedule be modified for the settlement agreement to be filed on or before September 6, 2013. The hearing would still commence on September 30, 2013 as currently scheduled, and all other aspects of the procedural schedule as set forth in the Procedural Orders would remain in full force and effect.


