
EXCEPTION TO RECOMMENDED OPINION AND ORDER

Transtelco, Inc. ("Applicant"), through its undersigned counsel, respectfully files this minor exception to the Recommended Opinion and Order ("ROO") filed in the above-captioned docket on August 23, 2013. In reviewing the ROO, Applicant realized that its Application in this matter incorrectly stated that Applicant is an S corporation. This mistake is included within the ROO at Finding of Fact No. 1. Applicant is, in fact, a C corporation. To the best of Applicant's knowledge, this distinction was not relied upon as material in either the Staff Report prepared in this matter or the ROO. Applicant supports the conclusions of the ROO and does not believe that this correction should impact the substance of the Commission's decision.

Through this filing, Applicant respectfully requests that the ROO be corrected to reflect that Applicant is a C corporation.
