

To All Parties:

On August 26, an incorrect APS notice describing Company's proposed deadlines for grandfathering in the Company's application for a net metering solution was docketed as public comment. APS is filing this letter to make clear to all parties that these deadlines are not currently in place at APS and have not been approved by the Commission. The notice was sent in error by APS to a limited number of customers requesting residential distributed energy incentives. It should have, but did not, make clear that the deadlines in the notice are proposals only. The Company has sent a follow-up notice to customers clarifying the guidelines.
