The Complainants enter a plea with this jurisdiction to postpone most of the issues in the complaint until the inspection of lines and poles be completed and a report created and submitted to all parties of interest.

Complainant has been contacted by Staff of the Arizona Corporation Commission stating that an inspection is going to be conducted on Mohave Electric Cooperative's High Voltage Transmission lines and poles from mile marker 66 to mile marker 80 along Hwy 66 East of Kingman, AZ. The issues in this complaint are about the safety, location of lines and location of buildings. Complainant has also been contacted by the Respondent's attorney that some type of scheduling is being proposed for this inspection.
