The Securities Division of the Arizona Corporation Commission, requests that the requirement that the Division make a filing on September 16, 2013, and the procedural conference in this matter scheduled to be held on September 23, 2013, both be vacated.

The September 23<sup>rd</sup> procedural conference regards a Commission subpoena issued to Clear Energy Systems, Inc. The subpoena requires CES to provide information that might aid respondents in proving a set-off of restitution ordered against Dedmon in a 2005 Commission order.

The Division and respondents are currently discussing a settlement regarding payment of the ordered restitution. Because such a settlement, if reached, could render moot the purpose of the procedural conference and the accompanying Division filing, the filing should not be required and the conference should be vacated.


