INC.'S MOTION TO CONSOLIDATE

Applicant Tusayan Water Development Association, Inc. ("TWDA"), through counsel, hereby moves for an order consolidating this docket with the recently filed docket, styled as Application for a Certificate of Convenience and Necessity – Water, filed by Hydro-Resources, Inc. ("Hydro"), together with the dockets for TWDA's original Application for Establishment of Rates [Docket No. W-02350A-10-0163], the Application for Adjudication Not a Public Service Corporation filed by Anasazi Water Co., LLC [Docket No. W-20765A-10-0432], and the Application for Adjudication Not a Public Service Corporation filed by Hydro [Docket No. W-2077A-10-0473].

All five dockets pertain to the same subject matter, the provision of water service to an area for which TWDA presently holds a Certificate of Convenience and Necessity in the vicinity of Tusayan, Arizona. TWDA's 2013 application for cancellation of the CC&N constitutes its performance of a settlement agreement reached in the 2010 dockets. Likewise, the 2013 docket filed by Hydro constitutes its performance of its obligations under the same settlement agreement.

1 All five dockets should be combined into a single proceeding and be heard and  
2 considered accordingly.


