BY THE COMMISSION:

Having considered the entire record herein and being fully advised in the premises, the Arizona Corporation Commission ("Commission") finds, concludes, and orders that:

FINDINGS OF FACT

1. On July 2, 2013, a Recommended Opinion and Order was docketed in the above-captioned matter and scheduled for consideration at the Commission's July 17, 2013, Open Meeting. The Recommended Opinion and Order was subsequently pulled from the July 17, 2013, Agenda. The Commission heard the matter at its August 13, 2013, Open Meeting and approved the Recommended Opinion and Order as amended.

2. Decision No. 74037 became effective August 16, 2013.

3. After the August 13, 2013, Open Meeting it was learned that certain dates in the Recommended Opinion and Order had not been revised to reflect the later Open Meeting date resulting in several incorrect effective and deadline dates. The Decision states as follows:

- Page 46, Lines 17 - 19: IT IS THEREFORE ORDERED that Clear Springs Utility Company, Inc. is directed to file with the Commission by July 31, 2013, a schedule of

the approved rates and charges for its Wastewater Division as set forth below:"

- Page 47, Lines 8 – 9: IT IS FURTHER ORDERED that the rates and charges set forth above shall be effective for all wastewater services rendered by Clear Springs Utility Company, Inc. on and after August 1, 2013.
- Page 47, Lines 25 – 27: IT IS FURTHER ORDERED that Clear Springs Utility Company, Inc. is directed to file with the Commission by July 31, 2013, a schedule of the approved rates and charges for the Water Division as set forth below:"
- Page 49, Lines 21 – 22: IT IS FURTHER ORDERED that the above rates and charges shall be effective for all water services rendered by Clear Springs Utility Company, Inc. on and after August 1, 2013.

4. Because the August 16, 2013, effective date of Decision No. 74037 post-dates the above-referenced time frames, the Decision should be corrected, *nunc pro tunc*, to reflect the following:

- Page 46, Line 18: delete: " July 31, 2013," and insert: "August 31, 2013,"
- Page 47, Line 9: delete: "August 1, 2013," and insert: "September 1, 2013."
- Page 47, Line 26: delete: " July 31, 2013," and insert: "August 31, 2013,"
- Page 49, Line 22: delete: "August 1, 2013," and insert: "September 1, 2013."

CONCLUSIONS OF LAW

1. Clear Springs Utility Company, Inc. is a public service corporation within the meaning of Article XV of the Arizona Constitution.
2. The Commission has jurisdiction over Clear Springs Utility Company, Inc. and over the subject matter of the applications.
3. Decision No. 74037 should be corrected, *nunc pro tunc*, as discussed herein.





IT IS THEREFORE ORDERED that Decision No. 74037 is hereby corrected *Nunc Pro Tunc* as follows:

- Page 49, Line 22, delete: "August 1, 2013," and insert: "September 1, 2013,"


IT IS FURTHER ORDERED that this Decision shall become effective immediately.
