1 All parties in the above-captioned matter hereby stipulate to partially continue the hearing
2 date in this matter currently set to begin October 21, 2013, and to continue through November 21,
3 2013. (See Fifth Procedural Order dated April 24, 2013). Counsel for Mogler, Tri-Core
4 Companies, LLC, Tri-Core Business Development, LLC, ERC Investments, LLC, and ERC
5 Compactors, LLC recently informed the Division that he has a conflict with a criminal matter set
6 for an 8-10 week trial beginning November 5, 2013, in which he is counsel of record for a
7 defendant (Maricopa County, CR2011-126239-002). Per counsel, that judge refused to continue
8 the trial or give priority to this hearing.

9 As such, the parties in the above-captioned matter have agreed to proceed with two weeks
10 of hearing scheduled to begin on October 21, 2013, to continue through October 31, 2013. The
11 parties have also agreed that the final three weeks of hearing can be rescheduled to a date in
12 February or March 2014. The parties further stipulate that Mogler, Tri-Core Companies, LLC, Tri-
13 Core Business Development, LLC, ERC Investments, LLC, and ERC Compactors, LLC shall be
14 permitted to wait to present their case in chief until the rescheduled dates of hearing in 2014.
