NOTIFICATION OF INTERVENTION

BY THE COMMISSION:

On July 1, 2013, Tucson Electric Power Company ("TEP" or "Company") filed with the Arizona Corporation Commission ("Commission") its 2014 Renewable Energy Standard and Tariff ("REST") Implementation Plan ("Plan").

On August 29, 2013, Arizonans for Electric Choice and Competition ("AECC") filed an Application to Intervene.¹ AECC is a coalition of energy consumers which has members who are customers of TEP.

No party objected to AECC's Request to Intervene.

IT IS THEREFORE ORDERED that AECC's request to intervene is granted.


