STAFF'S NOTICE OF FILING STATUS UPDATE

On July 3, 2013, the Administrative Law Judge assigned to this matter issued a Procedural Order directing "each party to... file in this docket an update providing the party's understanding of the status of sewer district formation for the Ehrenberg area, any pertinent supporting documentation, and the party's proposal regarding the process and schedule for this matter going forward" no later than October 1, 2013.¹ Responsive to that order, the Utilities Division ("Staff") of the Arizona Corporation Commission ("Commission") hereby provides notice of filing the following update.

Intervenors Robhana, Inc. and Charles Dunn Capital, Inc. (collectively "Robhana") have represented to Staff that efforts to form a sewer district for the Ehrenberg area are progressing favorably. According to Robhana, the formation of the sewer district may be finalized as early as November of 2013. As a result, Staff recommends that this matter continue to be held in abeyance pending the outcome of the sewer district formation. Staff further recommends that Robhana be

1 required to file another status update in sixty (60) days to address the status and progress of the sewer
