Dear Judge Nodes and Commissioners,

I am respectfully requesting that no final ruling be issued in the Phase 1 portion of this case until complete discovery of all pertinent documents is available on the docket. The ratepayers of Payson Water Company should be afforded more time to submit discovery of missing documents in the above referenced case. I have only been aware of any problems relating to water issues in Mesa del Caballo since 09/20/13, when I received my Public Notice advising of the Phase 1 hearing on 09/25/13. That's only 17 days now!

As per copies of my letters attached, today I am submitting Freedom of Information Act (FOIA) requests to obtain documents not currently available on the docket in this case, as I believe these documents are absolutely pertinent for a thorough analysis and understanding of this case.

As a ratepayer of the Payson Water Company, I have a vested interest in the outcome of this case, as I will be affected by the decision. Therefore, I respectfully ask for a delay in ruling until such time as pertinent information is available for public consumption.

At this time, I am strongly opposed to this case, based on the incomplete, inadequate and inaccurate information available on the docket to evaluate the exorbitant rate increase that is proposed.


