STAFF'S MOTION TO CONSOLIDATE

On September 30, 2011, Truxton Canyon Water Company, Inc. ("Truxton" or "Company") filed with the Arizona Corporation Commission ("Commission") an application for an increase in its water rates and charges (Docket No. W-02168A-11-0363). On September 11, 2013, the Company filed with the Commission an application for approval of a revision of the Company's existing terms and conditions of water service (W-02168A-13-0309). On September 30, 2013, the Company filed with the Commission an application for authority to incur long-term debt (Docket No. W-02168A-13-0332).

The issues in these cases are inter-related. For instance, the rates to be set in Docket No. W-02168A-11-0363 will be determined, in part, on any financing which is approved in Docket No. W-02168A-13-0332. Therefore Staff seeks the consolidation of these three dockets.

Staff further requests that the procedural schedule set for in the Procedural Order issued herein on October 2, 2013, remain in place, and that all three dockets shall follow said schedule. Staff counsel has conferred with counsel for the Company as well as counsel for Intervenor Valle Vista Property Owners Association, Inc.; neither opposes consolidation of these matters and maintenance of the existing procedural schedule.




