**STAFF'S REQUEST TO SUSPEND

On September 11, 2013, Truxton Canyon Water Company ("Company" or "Truxton") 30, 2011, filed an application for approval of a revision of the Company's existing terms and conditions of water service. A rate application for an increase in its water rates and charges was filed on September 30, 2011 and is pending in Docket No. W-02168A-11-0363. On September 30, 2013, the Company also filed an application for approval to incur long-term debt in Docket No. W-02168A-13-0332.

Utilities Division Staff ("Staff") has filed a motion to consolidate this matter with the rate application and the financing application. In addition, Staff has been advised by the Company that the application filed herein was incomplete and that it is re-filing a complete application.

Therefore Staff respectfully requests that the timeclock, as detailed in A.A.C. 14-2-103(B)(11), be suspended in this matter to allow for consolidation of the above-named pending applications.


