
**NOTICE OF FILING

In compliance with Decision No. 72665, Cricket Communications, Inc. ("Cricket"), through undersigned counsel, hereby files its quarterly report for the quarter ending September 30, 2013:

1. As of September 30, 2013, Cricket had 58,399 Lifeline subscribers in Arizona.
2. Cricket does not remove customers from its customer base due to 60-days inactivity.
3. Cricket performs its annual verification/recertification of Lifeline subscribers on an annual basis and not on a rolling basis. The results of the annual verification/recertification will be reported with the next quarterly filing.
4. With respect to voluntary relinquishment of service, 6,977 customers were disconnected due to non-payment of the monthly service charge for the quarter ending September 30, 2013.
