During the conferences Arizona Corporation Commission Staff ("Staff") and the applicant, Holiday Enterprises, Inc. dba Holiday Water Company ("Company") discussed, *inter alia*, the propriety of consolidating these matters and a timeline for the filing of Staff's Staff Report.
