PROCEDURAL ORDER

BY THE COMMISSION:

On July 3, 2013, Holiday Enterprises, Inc. d/b/a Holiday Water Company ("Company") filed an application with the Arizona Corporation Commission ("Commission") for a permanent rate increase under Docket No. W-01896A-13-0238 ("Rate Application"). Also on July 3, 2013, the Company filed an application for authority to incur long-term debt under Docket No. W-01896A-13-0239 ("Finance Application").

The Commission's Utilities Division ("Staff") docketed a Letter of Sufficiency in the Rate Application docket on July 31, 2013, advising the Company that its Rate Application met the sufficiency requirements of Arizona Administrative Code ("A.A.C.") R14-2-103, and that the Staff Report regarding the Rate Application would be docketed on approximately October 14, 2013.

Pursuant to Procedural Orders filed in each docket on August 13, 2013, concurrent procedural conferences were held on August 22, 2013, to discuss whether the two dockets should be consolidated.

On August 27, 2013, by Procedural Order, the above referenced dockets were consolidated, and an October 15, 2013 date for filing the Staff Report was established.

On October 15, 2013, Staff filed a Request for Extension of Time to File Staff Report from October 15, 2013 to October 18, 2013. Staff noted it had contacted the Company about the extension and the Company did not object.

1 Staff's Request for Extension is reasonable and shall be granted.


2 IT IS THEREFORE ORDERED that the **deadline for submission of the Staff Report is**
3 **extended to October 18, 2013.**

4 IS FURTHER ORDERED that the *Ex Parte* Rule (A.A.C. R14-3-113 - Unauthorized
5 Communications) applies to this proceeding and shall remain in effect until the Commission's
6 Decision in this matter is final and non-appealable.

7 IT IS FURTHER ORDERED that parties must comply with Rules 31 and 38, Rules of the
8 Arizona Supreme Court and A.R.S. § 40-243 regarding practice of law and admission *pro hac vice*.

9 IT IS FURTHER ORDERED that the Administrative Law Judge may rescind, alter, amend, or
10 waive any portion of this Procedural Order by subsequent Procedural Order or by ruling at hearing.
