Honorable Commissioners;

Recently it has been brought to my attention (including by Susan Bitter-Smith) that all correspondence to you may be more effective if it includes specific data rather than opinions. In regards to the consequences of APS'es efforts to kill distributed generation:

- 1) In the last two years, over 12 (to my knowledge) Arizona solar integrators have had to go out of business.
- 2) At least 3 solar equipment manufacturers have drastically reduced their production or moved out of here.
- 3) Therefore I estimate that a minimum of 350 people lost their jobs.
- 4) This equates to roughly \$700,000.00 in less tax revenue for our state. My solar design company has had to eat several thousand dollars when some of these solar integrators (my customers) closed.
- 5) Uncountable numbers of solar companies have shied away from starting in business or expanding here.
- 6) Indefinable numbers of students have decided to go to school in more renewable-energy friendly regions.
- How does one quantify the significant and possibly permanent damage to our reputation as "the # 1 solar state" (?)

Please put long-hard thought into these "statistics" when you judge whether to allow your netmetering requirements to be decimated or remain inplace. The net-metering method is not completely without flaws but it is universally accepted as a simple and just means of allowing homeowners and small business owners to receive fair credit for their contribution to the grid. It is an elegant solution because of it's simplicity and thus easily understood and embraced by citizenry (and should be sustainable without undue difficulties).

Dear Chairman Stump and Commissioners:



Dear Commissioners,

I am a voter and an SRP customer and I urge you to protect net metering: Docket #E-01345A-13-0248. APS and others recently came out with allegations that rooftop solar is a subsidy for the wealthy. It is not.

When I retired in 2008, I needed to reduce my fixed expenses because I live mostly on Social Security. In December, 2010 I used a home equity loan to invest in solar panels (net \$6400 after tax credits), and for almost 3 years, have enjoyed about 60% savings on my energy bills. I can't tell you how proud I am to tell my out-of-town friends and family that I save hundreds of dollars each year thanks to the "Arizona sun". I love this state and want us to be in the forefront of clean air, clean water, and clean energy in Arizona.

As you know, solar energy is in its infancy in Arizona and accounts for less than 2% of our electricity. Yet it already employs almost 10,000 Americans and cuts energy costs by reducing the need for new grid infrastructure and coal plants and cuts CO2 emissions. Yet, since 1985, nuclear and fossil fuels have received subsidies of almost 1 billion dollars – some for coal plants – which produce carbon emissions and ruin our water and air. (I saw this pollution directly in June when I visited Navajo National Monument.) The result is pollution, devastating respiratory and other health conditions for Native Americans, miners, and doesn't stop at a border from the rest of us. Another large part of subsidies were used for nuclear energy – yet we know that nuclear takes huge amounts of water from our drought-prone state, is subject to terrorist sabotage, and there is still no provision for its waste products! We need solar in this state not coal or nuclear energy!

So please reject the APS attacks against solar which attempt to place hefty taxes on rooftop net-metering. Lower income people especially need roof-top solar as electricity continues to escalate in cost. We should retrain and employ workers in solar energy, lower the costs of solar, and build a clean state which is a model of energy efficiency.
