The 2 consolidated cases pending before the ACC, docket #W-03514A-13-0111 and W-03514A-13-0142 should be dismissed as unlawful, pursuant to ARS § 40-361. I am in possession of evidence that proves an agreement was entered into last December (2012) to tie into the Town of Payson's new water treatment facility currently under construction for access to Cragin reservoir water. If Payson Water Company (PWC) wanted to pursue this expensive proposal, they should have held public meetings and properly advised the ratepayers of the 8 small communities that will be affected, allowing for full public disclosure and discussion of possible alternate solutions, cost/benefit analyses, etc. Instead, they deceptively asked the ACC for a "fast track" financing approval to secure the financing (debt) under false pretense of "avoiding water hauling next summer" when that claim has already been dismantled by testimony of Jason Williamson of PWC. The law requires "charges demanded or received by a public service corporation for any commodity or service shall be just and reasonable". That case has not been made and I allege that the \$1,238,000 debt is neither just nor reasonable for a water company with only 1,114 ratepayers. I demand a full review of the evidence before any order is issued.
