JOINT REQUEST FOR EXTENSION

On October 17, 2013, the Administrative Law Judge assigned to this matter issued a Procedural Order granting, *inter alia*, an extension of time for the Utilities Division ("Staff") of the Arizona Corporation Commission ("Commission") to file its Staff Report. Pursuant to that order, the deadline for Staff to file its Staff Report was extended to October 28, 2013.

Antelope Water Company, Inc. ("Company") has represented to Staff that it is in the process of resolving an important issue with another entity which will impact Staff's recommendations in this matter. In order to allow sufficient time for the Company to resolve that issue, Staff and the Company jointly request an additional fourteen (14) day extension for Staff to file its Staff Report. Staff notes that it will file its Staff Report as soon as that issue is resolved, even if prior to the requested deadline extension. Accordingly, the parties respectfully request that the current procedural dates be modified to allow the Staff Report to be filed no later than November 12, 2013<sup>1</sup> and, if necessary, a corresponding extension of time for the Commission to render a Decision in this matter.
