STAFF REQUEST FOR EXTENSION

11 On September 18, 2013, Staff filed its Staff Report in this consolidated matter. On September
 12 30, 2013, the Company filed its response to the Staff Report specifying six concerns with the Staff
 13 Report. On October 19, 2013, a procedural order was filed that required Staff to respond to the
 14 Company's filing by October 30, 2013. Staff has reviewed the comments to the Staff Report and
 15 believes that there may be modifications that could be made to the Staff recommendations within the
 16 Staff Report that would be responsive to the Company's concerns. Staff is continuing to develop
 17 appropriate modifications to the Staff recommendation at this time. Consequently, Staff requests an
 18 extension of its time to file a response until November 8, 2013 in order to prepare its responsive
 19 filing.

20 Staff has communicated this request to the Company and the Company has indicated that it
 21 has no objection to the extension.
