Unite Private Networks, LLC ("UPN" or the "Company"), by undersigned counsel, hereby notifies the Arizona Corporation Commission ("Commission") of its intent to continue to pursue a Certificate of Convenience and Necessity ("CC&N") to provide facilities-based private line telecommunications services in the State of Arizona ("Notice") and respectfully requests that the Commission reschedule a hearing in this docket. In support of this Notice, UPN states as follows:

1. UPN has demonstrated, through its original application for CC&N filed June 1, 2007, data responses filed August 13, 2007, November 28, 2011, and March 27, 2013, and additional information filed March 28, 2013, that it meets the requirements for authority to provide facilities-based private-line telecommunications services in the State of Arizona.

2. UPN timely published notice of the hearing scheduled for October 15, 2013, timely filed Affidavits of Publication, and fully intended to appear at the hearing. However, due to a misunderstanding, the Company planned to make its appearance telephonically and did not realize until the time of the hearing that it would not be allowed to do so. UPN

1 sincerely apologizes for the inconvenience caused to the Commission and to Staff.

2 3. Local counsel for UPN, Giancarlo Estrada of Estrada-Legal, PC, is entering
3 its appearance on the Company's behalf.

4 4. UPN intends to continue in its pursuit of a CC&N.

6 WHEREFORE, UPN respectfully requests that the Commission continue to process
7 its request for CC&N in the instant docket and issue a Procedural Order rescheduling the
8 hearing date.


