28 The Truxton Canyon Water Company, Inc. ("Truxton") hereby requests an
extension of time to provide the public notices for the rate and finance matters. In the
procedural order dated October 2, 2013, the Court ordered Truxton to mail and publish


1 the notice of rate application and hearing by October 30, 2013. In the procedural order
2 dated October 21, 2013, the Court ordered Truxton to file certification of public notice
3 for its finance application by October 28, 2013.

5 Prior to receiving the latest procedural order, Truxton had prepared to mail both
6 the rate and finance notices together to save the expenses. Truxton mailed both the rate
7 and finance notices to its customers on October 29-30, 2013. So although Truxton met
8 the rate case requirement, it could not have filed a certification of mailing by October 28,
9 2013. Meanwhile, Truxton has arranged for publication of the rate case and finance case
10 notices by Sunday, November 3, 2013. Truxton understands that the finance case notice
11 was published on October 31, 2013.

14 Therefore, Truxton requests that the Court grant Truxton an extension of time to
15 mail all notices by no later than October 30, 2013; publish all notices by no later than
16 November 3, 2013; and file all certifications by no later than November 19, 2013.
