STIPULATION BETWEEN ALECA AND TOTAL CALL MOBILE, INC.

Total Call Mobile, Inc. ("Total Call" or the "Company") and the Arizona Local Exchange Carriers Association ("ALECA") submit the following stipulation concerning Total Call's Application in this docket:

1. Total Call is seeking ETC designation throughout the entire State of Arizona, which includes certain lands of Federally Recognized Tribes in Arizona.
2. To address potential ALECA concerns with this requested designation, Total Call agrees that it will not provide Lifeline service to eligible residents residing on the lands of Federally Recognized Tribes in Arizona until Total Call has obtained any and all necessary licenses or other forms of approval that may be required by a Tribe. Before providing such service on tribal lands,

1 Total Call will file a copy of the tribal license or other form of approval with  
2 the Arizona Corporation Commission in Docket No. T-20870A-12-0500, with  
3 a copy to ALECA's undersigned counsel.

4 3. To ensure that Total Call does not inadvertently provide service to residents of  
5 the lands of a Federally Recognized Tribe for which Total Call has not  
6 obtained all necessary licenses or other forms of approval, Total Call further  
7 agrees that its Lifeline enrollment application for Arizona will:  
8

- 9 a. Require an applicant to provide a street address; and  
10  
11 b. Include a provision that requires an applicant under penalty of perjury  
12 (i) to self-certify that he or she does not reside on the lands of a  
13 Federally Recognized Tribe in Arizona, or (ii) to identify the Federally  
14 Recognized Tribe on the lands of which he or she resides.

15 If the applicant does reside on the lands of a Federally Recognized Tribe for  
16 which Total Call has not received the approvals identified in Paragraph 2,  
17 Total Call will not provide service to the applicant.

19 4. Given this stipulation, ALECA does not oppose Total Call's Application in  
20 this docket and does not believe that a hearing is necessary to address


