On July 12, 2013, Arizona Public Service Company ("APS") filed with the Arizona Corporation Commission ("Commission") an application for approval of a Net Metering Cost Shift Solution.

IT IS THEREFORE ORDERED that Albert E. Gervenack is hereby granted intervention.




