Verde Santa Fe Wastewater Co., Inc. ("VSF" or the "Company") hereby submits this Request to Vacate and Reset March 31, 2014 Public Comment Session in the above-captioned matter.


On November 5, 2013, VSF and the Utilities Division Staff ("Staff") of the Arizona Corporation Commission filed a stipulated request to modify the existing procedural schedule due to scheduling conflicts. The ALJ issued a procedural order on November 7, 2013, which effectively granted the Company and Staff's proposed case schedule and moved the hearing date from March 31 to May 5 of 2014. However, as a precaution, the ALJ retained March 31 for public comment and ordered the Company to make a filing explaining whether and to what extent notice of the March 31 date has been provided.

VSF affirms that it did not provide any notification to the public. Therefore, it is unnecessary to retain March 31, 2014 for public comment. The Company respectfully

1 requests the ALJ vacate that date and reset public comment for May 5 at 10:00 a.m.
2 VSF has not yet provided notice and will now consistent with the new schedule.
