PROCEDURAL ORDER
(Modifying Procedural Schedule)

BY THE COMMISSION:

On April 26, 2013, Chaparral City Water Company ("CCWC" or "Company") filed the above-captioned rate application with the Arizona Corporation Commission ("Commission").

A hearing on the application has been set to commence on February 18, 2014.

Intervention has been granted to the Residential Utility Office ("RUCO"), the Town of Fountain Hills ("Town"), Lina Bellenir, Gale Evans, Patricia Huffman, Leigh M. Oberfeld-Berger, Tracey Holland, and Leonora M. Hebenstreit.

On November 15, 2013, RUCO filed a Motion for Extension of Time to File Testimony ("Motion"). The Motion requests that the current procedural schedule be modified as follows:

1 The Motion states that Staff joins in the Motion. RUCO states that the Company has been
2 cooperative in providing discovery, but that RUCO and Staff both require more time to prepare their
3 Direct Testimony. RUCO believes that the proposed procedural modifications should provide
4 sufficient time to prepare Direct Testimony if the Company timely complies with outstanding
5 discovery requests.

6 No party has objected to the proposed procedural schedule modifications. The relief
7 requested in the Motion is reasonable and should be granted.

8 IT IS THEREFORE ORDERED that the deadlines for the filing of Direct Testimony, Rate
9 Design Direct Testimony, Rebuttal Testimony and Surrebuttal Testimony are hereby extended as
10 requested in the Motion.

11 IT IS FURTHER ORDERED that all other procedural deadlines set forth in the Procedural
12 Orders issued on June 17 and 18, 2013 remain in place.

13 IT IS FURTHER ORDERED that the Administrative Law Judge may rescind, alter, amend,
14 or waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at
15 hearing.
