PROCEDURAL ORDER
(Extending Deadlines)

BY THE COMMISSION:

On June 20, 2013, Antelope Water Company, Inc. ("AWC" or "Company") filed with the Arizona Corporation Commission ("Commission") an application for a permanent rate increase ("Application").

On August 5, 2013, the Commission's Utilities Division ("Staff") notified the Company that its Application was sufficient pursuant to the Arizona Administrative Code ("A.A.C."), and classified AWC as a Class E public utility. Staff indicated that the Staff Report on the Application would be docketed on or about October 4, 2013, and the Commission's Decision should be rendered on or before December 3, 2013, barring any substantial amendments to the filing or extraordinary events.

On October 4, 2013, Staff filed a Request for Extension, stating it needed additional time to prepare the Staff Report due to constraints on resources. Staff requested that the filing deadline for the Staff Report be extended from October 4, 2013, to October 14, 2013. Staff noted it had contacted AWC about the extension and the Company did not object.

A Procedural Order granting Staff's Request for Extension was docketed on October 9, 2013, extending the filing deadline for the Staff Report to October 14, 2013.

Staff filed a Request to Alter Filing Date on October 9, 2013, noting that October 14, 2013, is a State Holiday and requested that the filing deadline reflect an October 15, 2013, filing deadline.

On October 16, 2013, a Procedural Order was issued granting Staff's request.

On October 15, 2013, Staff filed a Request for Extension, stating it needed additional time to prepare the Staff Report and requesting that the filing deadline for the Staff Report be extended to

1 October 28, 2013. Staff noted it had contacted AWC about the extension and the Company did not
2 object.

3 A Procedural Order granting Staff's extension request was docketed on October 17, 2013.

4 On October 25, 2013, Staff and AWC docketed a Joint Request for Extension in which Staff
5 explained that the Company was attempting to resolve an issue with another entity that may affect
6 Staff's recommendations in this matter. Staff and AWC requested an extension of the October 28,
7 2013, Staff Report filing deadline in order to allow time for the Company address the issue.

8 On October 30, 2013, a Procedural Order was issued granting the Joint Request and extending
9 the Staff Report filing deadline to November 15, 2013.

10 The parties filed a second Joint Request for Extension on November 15, 2013, stating that
11 AWC is still attempting resolve an issue that may impact Staff's recommendations. AWC and Staff
12 requested an extension of 31 days to file the Staff Report.

13 The parties' extension request is reasonable and shall be granted.

14 IT IS THEREFORE ORDERED that the **deadline for submission of the Staff Report is**
15 **extended to December 16, 2013.**

16 IT IS FURTHER ORDERED that the **deadline for rendering a Decision in this matter is**
17 **revised to reflect an extension to February 18, 2014.**¹

18 IT IS FURTHER ORDERED that the *Ex Parte* Rule (A.A.C. R14-3-113 - Unauthorized
19 Communications) applies to this proceeding and shall remain in effect until the Commission's
20 Decision in this matter is final and non-appealable.

21 IT IS FURTHER ORDERED that all parties must comply with Rules 31 and 38 of the Rules
22 of the Arizona Supreme Court and A.R.S. § 40-243 with respect to practice of law and admission *pro*
23 *hac vice*.

24 IT IS FURTHER ORDERED that the time periods specified herein shall not be extended
25 pursuant to Rule 6(a) or (e) of the Arizona Rules of Civil Procedure.

28 ¹ Thirty-one days from January 17, 2014 is February 17, 2014, which is a Holiday.

1 IT IS FURTHER ORDERED that the Administrative Law Judge may rescind, alter, amend,
2 or waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at
3 hearing.


