

16 Having considered the entire record herein and being fully advised in the premises, the  
17 Commission finds, concludes, and orders that:

18 **FINDINGS OF FACT**

19 1. On October 25, 2013, the Arizona Corporation Commission (“Commission”) issued  
20 Decision No. 74174 which approved an application for approval of the sale of North Mohave Valley  
21 Corporation’s (“NMVC”) assets and transfer of its Certificate of Convenience and Necessity  
22 (“Certificate”) to EPCOR Water Arizona, Inc. (“EPCOR”).

23 2. As a condition of the Commission’s approval, EPCOR was required to do the following:

- 24
- 25 • that EPCOR file, within 60 days of the effective date of the Decision, with the  
26 Commission’s Docket Control, as a compliance item in this docket, the cross-  
27 connection and back-flow tariff for NMVC’s certificated area; and
  - 28 • that EPCOR file, within 60 days of the effective date of the Decision, with the  
Commission’s Docket Control, as a compliance item in this docket, EPCOR Mohave  
Water District’s (“EPCOR Mohave”) Best Management Practices (“BMP”) Tariffs  
for NMVC’s certificated area.

IT IS THEREFORE ORDERED that EPCOR Water Arizona, Inc. is hereby granted an extension of time, until January 31, 2014, to file copies of the required documentation as set forth hereinabove and described in Decision No. 74174 as follows: the cross-connection and back-flow tariff for North Mohave Valley Corporation's certificated area and EPCOR Mohave's BMP Tariffs for North Mohave Valley Corporation's certificated area.

IT IS FURTHER ORDERED that this Decision shall become effective immediately.
