COLUMBUS' MOTION TO  
AMEND PROCEDURAL ORDER

On July 23, 2013, Columbus Electric Cooperative, Inc. ("CEC") filed with the Arizona Corporation Commission, and Application for a rate increase.

On August 21, 2013, CEC received a Sufficiency Notice, pursuant to A.A.C. R14-2-103.B.7.

On August 30, 2013, a Rate Case Procedural Order was issued wherein CEC was required to mail and publish the Public Notice on or before October 31, 2013.

CEC mailed the Public Notice on October 24 and 31, 2013.

In the June, 2013, *Enchantment* magazine, which is sent to all CEC's consumer/members monthly, a Notice of Proposed Rate Change was included that detailed the proposed new rates for New Mexico and Arizona. However, CEC inadvertently failed to publish the Public Notice included in the aforementioned Rate Case Procedural Order.

The affected and remaining deadlines in the Rate Case Procedural Order are as follows:

- November 29, 2014 Intervention
- December 6, 2013 Direct Testimony (excluding rate design and cost of service) from Staff and/or Intervenors
- December 20, 2013 Direct Testimony on rate design and cost of service from Staff and/or Intervenors
- January 20, 2014 Rebuttal Testimony from CEC
- January 31, 2013 End of Phase I of discovery
- February 18, 2014 Surrebuttal Testimony from Staff and/or Intervenors

1 February 28, 2014 Rejoinder Testimony from CEC  
2 March 6, 2014, Hearing

4 CEC proposes the following amendments:

5 December 20, 2013 Intervention  
6 January 6, 2014 All Direct Testimony from Staff and/or Intervenors

7 All remaining deadlines will remain unchanged from the original Rate Case Procedural  
8 Order.

9 CEC has arranged for publication of the Public Notice, as amended herein, on December  
10 6, 2013, in the Hidalgo County Herald and December 11, 2013, in the Arizona Range News and  
11 Willcox Range News.

12 CEC has notified Staff of the oversight and the parties have agreed to amending the  
13 deadlines as stated below.
