
NOTICE OF PRICE INCREASE

Attention EarthLink Business Customers - On your January 2014 invoice you will see a 5% increase in the monthly recurring charges for certain services and features in each of the following categories of service if applicable to your service package: data, internet, local and long distance voice service. As an example, if your current call waiting rate is \$14.00, the new rate will be \$14.70. In addition, if any of the following fees are applicable to your service package, you will see the following increases: the Carrier Cost Recovery Fee (CCRF) will increase from \$.40 to \$.80; the Regulatory Cost Recovery Fee (RCRF) will increase from 3.5% to 7% of interstate/international charges; and the Administrative Service Fee (ASF) will increase as follows: (i) for Customers billing up to \$9,999.99, the ASF will increase from 2.5% to 5% of monthly recurring charges (MRCs); (ii) for Customers billing \$10,000 to \$24,999.99, the ASF will increase from 1.5% to 3% of MRCs; and (iii) for Customers billing \$25,000 and above, the ASF will increase from 1% to 2% of MRCs. The Administrative Support Charge will increase as noted on the reverse side of this notice.
