MOTION TO SCHEDULE**

**PREHEARING CONFERENCE**

**(Rule R14-3-108(A))**

Complainant hereby moves the Commission for an Order under Rule R14-3-108(A) setting the date for a Prehearing Conference as soon as practicable for the Hearing Officer assigned to this case but with adequate notice to the parties to prepare for the Conference.

The Complaint herein was filed on 24 September 2013 and the Answer on 23 October 2013, but no further proceedings have been had nor scheduled since that time. Complainant submitted a list of proposed stipulations to Respondent's attorney on 1 November 2013, but he is refusing to respond until after the conclusion of the Prehearing Conference. In the meantime, Respondent's customers continue to suffer in ignorance of the Monthly Weather Adjustment Charge and Respondent continues to refuse Complainant's settlement request for itemization because it says that its customers would be "confused" by additional line items.<sup>1</sup>

<sup>1</sup> Since Complaint is an old man of 75 years, he respectfully requests that the Commission avoid the following dates in 2014 now set for his health care: March 5<sup>th</sup> and March 6<sup>th</sup>. He also requests the avoidance of April 23<sup>rd</sup> through April 30<sup>th</sup>, when he will be out of Arizona. Complainant will schedule future health care appointments to avoid conflicts with dates set by the Commission.
