PROCEDURAL ORDER

BY THE COMMISSION:

By Procedural Order dated September 12, 2013, this matter was set for hearing on May 8, 2014, and other procedural deadlines established.

On January 28, 2014, Farmers Water Co. ("Farmers" or "Company") and the Arizona Corporation Commission ("Commission") Utilities Division ("Staff") filed a Joint Motion to Modify Procedural Schedule. The parties request a modification of the procedural schedule established in the September 12, 2013 Procedural Order, by pushing back approximately one week the deadlines for filing testimony. The hearing remains unchanged under the parties' proposal. The request was prompted by the Company's request for an extension of time to respond to Staff's Third Set of Data Requests issued on January 21, 2014, because of employee workload issues.

Under the circumstances, the parties' request is reasonable and is in the spirit of cooperation encouraged by the September 12, 2013, Procedural Order.


IT IS THEREFORE ORDERED that the filing deadlines for written testimony originally established in the September 12, 2013 Procedural Order are modified as follows:


