STAFF'S MOTION FOR EXTENSION

The Utilities Division ("Staff") of the Arizona Corporation Commission ("Commission") hereby files its request for an extension of time to file its Direct Testimony in the above-captioned matter.

On April 26, 2013, Chaparral City Water Company ("CCWC" or "Company") filed the above-captioned rate application with the Arizona Corporation Commission ("Commission").

A hearing on the application has been set to commence on February 18, 2014.

On November 20, 2013, a Procedural Order was issued setting forth the dates on which the parties' testimony would be due, with Direct Testimony being due on December 9, 2013. Staff now requests an extension of time for the filing of testimony in Order to fully address the issues in this case, while maintaining the current hearing date. The Company is in agreement with Staff's proposal, and Residential Utility Office ("RUCO") is in agreement with an extension of time, though not with the schedule Staff proposes for Surrebuttal and Rejoinder Testimony.




