

STATUS REPORT


On September 18, 2013, Utilities Division Staff ("Staff") filed its Staff Report in the above captioned matter. In response, Humboldt Water Systems, Inc. ("Humboldt" or "Company") filed responsive comments on September 30, 2013. Based on the specific concerns raised by the Company's comments, a procedural order dated October 9, 2013 required Staff to file a response to Humboldt's comments by October 30, 2013. Humboldt was granted an opportunity to respond to the Staff Response by November 20, 2013. Likewise, Staff and the Company were directed to engage in discussions regarding the comments raised in Humboldt's September 30 filing and to file a status report regarding the extent to which agreement could be reached as to those outstanding disputes.

On October 30, 2013, Staff filed a request for extension to file its response. On November 12, 2013, Staff docketed an Amended Staff Report that addressed the comments raised by the Company. Since the filing of Staff's Amended Staff Report, Staff has engaged in email communications with Company owner Tim Kylo. The email attached as Attachment A to this pleading is from Mr. Kylo and expresses general agreement with the Staff recommendations in the Amended Staff Report. Staff
