

RE: Application for Authorization for the Purchase of Generating Assets from Southern California Edison; Docket No E-01345A-10-0474

In Decision No. 73130, dated April 24, 2012, the Commission ordered:

That upon consummating the acquisition of Southern California Edison's interest in Four Corners Units 4 and 5, Arizona Public Service Company shall notify the Commission by making a compliance filing in this docket within ten business days after closing and thereafter make compliance filings on a quarterly basis updating the Commission on its progress retiring Units 1-3, with a goal that retirement occur by December 31, 2013.

APS hereby informs the Commission that on December 30, 2013, APS consummated the transaction with the Southern California Edison to acquire their interest in Units 4 and 5. APS will shut down and retire Units 1-3 by year end, and therefore this is the last compliance report that will be submitted.
