NOTICE OF COMPLETION OF COMPLIANCE FILINGS

Pursuant to Decision No. 70360 (May 27, 2008) and the related approved Plan of Administration ("POA"), UNS Electric, Inc. ("UNS Electric"), is required to submit its Purchased Power and Fuel Adjustment Clause ("PPFAC") Rate filing annually on December 31st. In UNS Electric's recently approved Rate Application, Docket No. E-04204A-12-0504, the PPFAC POA and application of the PPFAC were revised. The PPFAC is now a monthly rate that is posted on the Company's website, <https://www.uesaz.com/>. The filings requirements from the POA approved in this docket were superseded by the filing requirements approved in the POA in Docket No. E-04204-12-0504. UNS Electric will no longer be filing PPFAC-related documents in this docket.




