
**LEAP FROG TELECOM, L.L.C. DBA VOCE TELECOM
QUARTERLY COMPLIANCE REPORT
DUE DECEMBER 31, 2013**

Pursuant to Decision No. 74151 issued on October 25, 2013 in Docket No. T-20584A-10-0319, par. 57, Leap Frog Telecom, L.L.C. dba Voce Telecom ("Voce") submits this Quarterly Compliance Report for 4th Quarter of 2013

Voce is in compliance with all Commission rules and orders and all laws administered by the Arizona Corporation Commission, and there have been no violations of such rules, orders or laws during quarter covered by this report.

During the quarter covered by this report, there has been one regulatory compliance issue or complaint in the other jurisdictions in which Voce operates, including the FCC's interstate jurisdiction. Specifically, Voce has been cited in a Formal Complaint issued in Proceeding No. 13C-1033T by the Public Utilities Commission of the State of Colorado for failure to file its 2012 Annual Report. Voce is working to satisfy this compliance item and has undertaken specific action to avoid such issues going forward. Specifically, subsequent to receiving the Colorado complaint, Voce contracted with Technologies Management, Inc. for compliance reporting services, which will include calendaring of standard federal and state regulatory reports applicable to Voce's operations, as well as reminders to ensure timely compliance.

The facts above set forth herein are true and correct to the best of my knowledge, information, and belief.
